

# **Regulations Governing Scholarship Programs for Foreign Students at Minghsin University of Science and Technology**

Article 1. The "Regulations Governing Scholarship Programs for Foreign Students at Minghsin University of Science and Technology" was drafted for the purpose of encouraging foreign students to apply for admission to Minghsin University of Science and Technology (MUST). It also grants foreign students' tuition fee and living expenses. Moreover, it aims to improve the internationalization of the University.

Article 2. The term "foreign students" as used in these regulations shall mean foreign students as specified in the "Admission Regulations of Minghsin University of Science and Technology (MUST) for Foreign Students". All foreign exchange students from our sister schools that have got the matriculation of MUST are welcome to apply for the scholarship in accordance with this formula.

Article 3. All application documents shall be submitted to the Office of International Affairs. All documents are subject to review by the department in accordance of applicant's major. The list will then be reviewed and finalized by the committee of scholarships.

Article 4. Applicants who meet one of the following criteria may file for application of the scholarship - recognized as excellent by the office of international affairs or the department of MUST based on the grade system of the applicant's nation without any record of misconduct, recommended by their original school, demonstrating outstanding performance records. Undergraduate applicants must present total GPA from high school.

Article 5. Full Tuition scholarship, which grants full tuition fee waiver, is limited to a maximum of 15 students per year. Bachelor Degree students can apply for 4 consecutive years. Master Degree students can apply for 2 consecutive years.

Article 6. Elite Mandarin scholarship, which grants NT20,000 per semester is limited by the government grant or school budget of the year. The applicants who meet one of the following criteria are eligible for this scholarship - Chinese as native language, the TOCFL Level 3 or above, identified by MUST or other Chinese language center as equivalent to TOCFL Level 3 or above, other certificate equivalent to TOCFL Level 3 or above. The Bachelor Degree and Master Degree students can apply for 2 consecutive years.

Article 7. Living Expenses scholarship, which grants NT5000 per month and up to 12 months is limited by government grant or school budget of the year. If the applicant is an instructor of a foreign university or has outstanding record, the Living Expenses scholarship can be raised. Bachelor Degree students can

apply for 4 consecutive years. Master Degree students can apply for 2 consecutive years.

Article 8. The student is obliged to work as a teaching assistant or a research assistant if he/she obtains the Full Tuition scholarship or Living Expenses scholarship

Article 9. Applicants who have received grant of scholarships from the government are not eligible to apply this scholarship.

Article 10. These regulations shall be reviewed in the administration meeting and approved by the school President. The same shall apply to any amendments.
